



## THE DOF IN 2013: CELEBRATING 5 YEARS OF LENDING!!!

In early 2009, we at the DOF closed our first loan to the Cottage in Darien and enjoyed watching six young adults with developmental disabilities move into their own home. Five years later, they are enjoying independent and productive lives in a community near their families.

During the same five years, we have grown to over \$8,000,000 in assets and closed an additional 25 loans in 9 states. Those loans financed the creation and redevelopment of 52 group home units, 417 accessible apartments, 220 classroom slots or “desks” in schools designed for persons with disabilities and 15,000 square feet of community facilities. And while these are important barometers of success, the DOF continues to have its greatest impact as “change agents” by providing technical assistance to over 1,000 families and by co-hosting, with various Federal Reserve Banks, eight Roundtable Discussions with over 950 attendees.

## We Help Create:


**One story:** Good Neighbor Homes (community center): With a mission to support individuals and families in achieving a life of opportunity, independence and growth, GNH operates a 7,300 square foot community center in Richmond, VA to provide socializing, health & wellness, community integration and personal growth day services for adults living with intellectual & developmental disabilities. The State of Virginia, like other states, has been moving toward a model of closing state run facilities and shifting to privately run residential and day centers. GNH began leasing the property from Scioto which utilized \$450,000 from the DOF to finance the acquisition of the building.

## We Participate: SANDY UPDATE

We continue to respond to many requests from individuals and organizations regarding financing and technical assistance for “Sandy-affected” losses. Our initial work was recognized by the Robin Hood Foundation with a \$250,000 grant. A recent \$60,000 grant from the American Red Cross will allow the DOF to continue these efforts in 2014.

In October 2013, we were honored to be selected by Capital One Bank to receive a \$5,000 Financial Literacy Challenge Grant – our second consecutive award! As one of 25 not-for-profits on Long Island selected through a competitive process, this grant will allow us to continue teaching people with disabilities and their families critical financial and transition planning tools.
